What is a Legacy Gift?

A Legacy Gift is a planned future donation to a charity, given through your will or other form of beneficiary designation. It can take any number of forms, which are described in greater detail in this pamphlet.

What are the Benefits of Legacy Giving to St. Mark's?

- Your gift shows your love for God and your neighbor.
- Your gift can truly change the world for the Kingdom of God.
- Your gift can continue to support missions and programs that have been important to you during your Christian life.
- Many studies show that charitable giving can contribute to greater happiness, improved life satisfaction, and less stress in your life.
- Charitable gifts can reduce your tax burden.

St. Mark's Giving Policy

There are many opportunities and ways to make Legacy Gifts to St. Mark's:

- ➤ **Designated gifts** go to the activity, organization, or fund designated by the giver (Ex: Revitalization, Dedicated Accounts, Endowment Funds, Montessori School).
- ➤ Undesignated gifts less than \$10,000 are directed to the Mission Endowment Fund.
- ➤ Undesignated gifts of \$10,000 or more are directed as follows:
 - o Tithes and Offerings
 - 10% Synod and ELCA Missions
 - o St. Mark's Lutheran Church
 - 30% Endowment Funds (allocated ³/₄ Mission Fund, ¹/₄ Youth Fund)
 - 30% Debt Reduction and Capital Programs
 - 30% Evangelical Outreach
- > St. Mark's Endowment Funds:
 - o Mission Fund
 - St. Michaels Youth Fund

Benevolences. St. Mark's generously supports important ministries such as Lutheran Social Services, World Hunger, ECHO, Caroline Furnace and Mar-Lu-Ridge, and Food for Others to name a few.
